

## Ercros informs about the announcement of the purchase of own shares

The Company informs that, under the sixth program for the repurchase of treasury shares to be redeemed, during the period between September 17 and 27, 2021 has carried out the purchase of 65,000 treasury shares.

Currently, the Company holds 1,936,612 treasury shares (1.92%).
