RELEVANT INFORMATION

As a continuation of the relevant information number 9962 published on June 11, 2021, the Company informs that, under the sixth program for the repurchase of treasury shares to be redeemed, between February 14 and 22, 2022 has carried out the purchase of 320,125 treasury shares.

Currently, the Company holds 3,001,551 treasury shares (2.97%).
